

The West Bengal Forest and Biodiversity Conservation Society, a registered society constituted under the aegis of Government of West Bengal, is implementing the Project for Forest and Biodiversity Conservation for Climate Change Response in West Bengal through Project Management Unit (PMU). The Society intends to appoint Statutory Auditor for conducting Statutory Audit of the accounts of Society for the Financial Year 2025-26. Quotation is therefore invited from bona fide Chartered Accountant firms fulfilling the following Pre-Qualification Criteria to carry out the Statutory Audit for the Financial Year 2025-26 for the Society.

2. Pre-Qualification Criteria
